On receipt of the letter from the party, the Dy. Chief Fire Officer from this section visited & inspected the site on 25/10/2016 to verify & ensure the compliance of all fire protection & fire fighting requirement stipulated by this department vide above referred Provisional Fire N.O.C. and it was observed that party has complied with the fire protection & fire fighting requirement stipulated by this department vide above referred provisional fire N.O.C.

The fire protection system was tested physically & found to be working satisfactorily on the day of inspection. The party has produced certificate of fire contractor ('M/s. Mamta Engineering' License No. MFS-LA/F-0301/D. A form certificate no. ME-013A-16-17) for providing fire fighting installations.

In view of above as far as this department is concerned there would be no objection to allow the party to occupy & use the said educational building. (height of building is 12.400 Mtrs.) However it shall be responsibility of occupiers/owner to maintain the fire safety measures in good working orders all the time.

Further as per the Maharashtra Fire Prevention & Life Safety Act, 2006 it is statutory requirement to check the in-built fire protection system from licensing agency twice in a year (in the month of January & July) & produce the certificate to this department.
